The undersigned incorporator, for the purpose of forming a corporation under the Florida Not-For-Profit Corporation Act, hereby adopts the following Articles of Incorporation.

ARTICLE ONE

NAME

The name of the Corporation is FIRST PRIORITY PALM BEACH COUNTY, INC.

ARTICLE TWO .

PRINCIPAL OFFICE

PURPOSE
