ARTICLE I - NAME

The name of this Corporation is: BRIDE OF CHRIST FAITH FELLOWSHIP
TABERNACLE, INC.

ARTICLE II - AFFILIATION

This Non-Profit Corporation is a member of Faith Fellowship Ministries, Inc. / Faith Fellowship Assembly, Inc. and is pledged to promote and fulfill it's purpose.

ARTICLE III - PURPOSE

This is a Non-Profit Corporation organized and operated exclusively for exempt purposes within the meaning of Section 501 (c)(3) of the Internal Revenue Code of 1954, as amended, including the following purposes:

a) Religious; b) To conduct a local church by the direction of the Lord Jesus Christ and under the leadership of the Holy Spirit in accordance with all of the commandments and provisions as set forth in the Holy Bible; c) To minister the Word of God to the faithful; d) To conduct a religious worship service through various forms of ministry; e) To promote and encourage, through the ministry of the organization, cooperation with other organizations ministering within the community; f) To spread the Word of the Gospel through seminars, radio, and other forms of mass media for the purpose of educating the individual in the Word of God; g) To acquire and hold such property, either real or personal, for Church purposes, as may be necessary for its membership in the worship of God.

ARTICLE IV - EXISTENCE

The period during which the Corporation shall continue is perpetual.

ARTICLE V - REGISTERED OFFICE

ARTICLE VII - MEMBERSHIP

Membership in this Corporation is granted on application to those who subscribe to and adhere to the doctrine of the full gospel message as outlined in the Articles of Faith of Bride of Christ Faith Fellowship Tabernacle, Inc..

ARTICLE VIII - MANAGEMENT OF AFFAIRS

The management of the affairs of the corporation is vested in the Pastor and the Board of Directors. The Corporation shall be governed by the provisions contained in its' Constitution and By-Laws. The Pastor, until his voluntary resignation or death is:

ARTICLE X - PROPERTY

Section 1. Documents relating to the conveying or encumbering real estate shall be signed by the Pastor/President and another Board member being the Secretary.

Section 2. In the event of a defection of any members of this Corporation from its' Articles of Faith, or from affiliation with Bride of Christ Faith Fellowship Tabernacle, Inc., the title of all Corporation property, real or personal, shall remain with those members abiding by such Articles of Faith and retaining affiliation with Bride of Christ Faith Fellowship Tabernacle, Inc.

Section 3. In the event of the dissolution of this Non-Profit Corporation, all its' property shall pass to an organization as determined by the Board of Directors of this Corporation whose purpose is in harmony with the full gospel message as outlined in this Corporation's Articles of Faith. Such organization must be organized and operated exclusively for the purpose specified in Section 501 (c)(3) of the Internal Revenue Code.

ARTICLE XI - AMENDMENTS

These Articles may be amended by a two-thirds vote of the members present and voting at the annual meeting or a special meeting called for that purpose, providing that all members are notified in written form a minimum of fourteen (14) days prior to the special called meeting. The Pastor/President and Secretary must be present at said meeting.
