## NONPROFIT ARTICLES OF INCORPORATION

### ARTICLE I

#### Name

The name of the nonprofit corporation shall be:

**MINISTRY OF FAITH DELIVERANCE, INC.**

### ARTICLE II

#### Principal place of business and mailing address

The principal place of business and mailing address of this corporation shall be:

### ARTICLE III

#### Purpose

The general nature of the business to be transacted by the corporation and the powers and rights of the corporation shall include any or all lawful business.

The general purposes and objects of this corporation shall be to conduct for religious worship and instruction, churches, schools, parsonages, and other institutions connected therewith of a religious, educational, charitable and benevolent character and to advance spiritual growth and enlightenment, moral and personal purity among its own membership and the people of the community in which it is located. For the purpose of promoting the foregoing objects, this corporation shall have the right to acquire, either by gift or purchase, and to hold, own, sell, mortgage or encumber in any manner, lease and improve real estate and personal property for itself and others, either as trustee or otherwise.

In general, to carry on any other business with all powers conferred upon corporations by the law of the State of Florida.

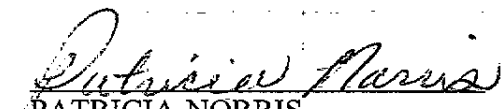
##### **Distribution of Assets Upon Dissolution or Final Liquidation**

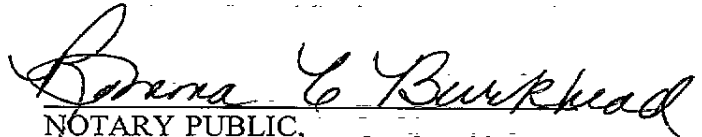

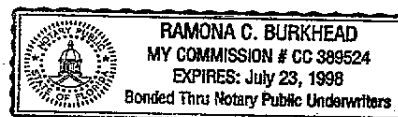

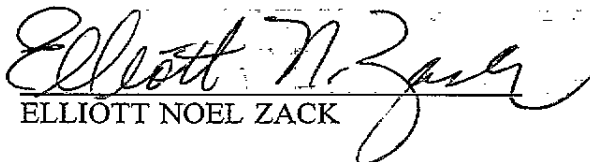
