ARTICLES OF INCORPORATION

The undersigned, acting as incorporator of a corporation pursuant to chapter 617, Florida Statutes, adopt the following Articles of Incorporation:

ARTICLE I

The name of the corporation shall be: the Delta foundation, inc.

ARTICLE II

The principal place of business and mailing address shall be: 2022 Northeast 121st Road, North Miami, Florida 33181.

ARTICLE III

The specific purposes for which the corporation is organized are: To generate services and programs which seek to promote the welfare of definite groups, such as: services for handicapped adults and children, programs to aid elderly persons in their pursuit for a better quality of life, and special services to adults and children who suffer any type of chronic or terminal illness. Other aims include the dissemination of information, in order to better educate members of particular ethnic groups, and other charitable and public service endeavors within the educational and scientific fields.

ARTICLE IV

The manner in which the directors are elected or appointed is as follows: The board of directors will consist of four members. The directors shall be appointed in the manner and for the terms provided in the bylaws.

ARTICLE V

The corporate powers of this corporation are as provided in section 617.0302, Florida Statutes.

ARTICLE VI

The name and address of the initial registered agent is: Mimi M. Korman, 2022 Northeast 121st Road, North Miami, Florida 33181.

- 2. The only provisions not inconsistent with the law, regarding the regulation of the internal affairs of the corporation, are as follows: 1)The signature of both, the president and the treasurer will be required in every corporate check. 2)Quorum will consist of 2 board members and 2 officers.
- 3. Any director may be removed from office pursuant to procedures provided by the corporation bylaws which include every condition contained in 617.0808, Florida Statutes. Directors shall be elected at an annual meeting of the members!
- 4. Membership will be non-transferable.
- 5. Assets will be distributed among other non-profit organizations or charitable institutions, as designated by the board members and officers.
- 6. The corporation membership consists of only two classes of members: officers and directors.
- 7. The initial members of the corporation are as follows: Julio Sánchez, Chairman of the Board Janet Perales, Member of the Board

- 8. The corporation will not be subordinate to the authority of any head or national association, fraternal or beneficial society, foundation, federation, or other corporation, society, organization, or association for profit.
- 9. Provisions set forth in the articles of incorporation need not be set forth in the bylaws.
- 10. The articles of incorporation need not set forth any of the corporate powers enumerated in section 617.0302, Florida Statutes.
