ARTICLES OF INCORPORATION

OF

THE ARABIC EVANGELICAL CHURCH OF DAYTONA BEACH, INC.

The undersigned desiring to form a not-for-profit corporation pursuant to Chapter 617, Florida Statutes, does for the purposes and objects hereinafter stated, agree, declare and adopt the following articles of incorporation for such corporation.

ARTICLE I - NAME

The name of the corporation is **THE ARABIC EVANGELICAL CHURCH OF DAYTONA BEACH, INC.**

ARTICLE II - PRINCIPAL OFFICE

The street address of the initial principal office of the corporation is 3000 S. Peninsula Drive, Daytona Beach Shores, Florida 32118 and the mailing address shall be the same.

ARTICLE III - TERM OF EXISTENCE

The period of duration of this corporation is perpetual and Corporate existence shall commence with filing of the Articles of Incorporation with the Secretary of State.

ARTICLE IV - CORPORATE NATURE AND PURPOSES

The primary purposes and objects for which the corporation is organized shall be:

1. For religious, educational and charitable purposes.
2. For the establishment of a church and other activities and institutions related to the purposes of the

corporation.

3. To take an active interest in the religious, civic, cultural, social and moral welfare of the community.

4. To unite the community in the bonds of friendship, good fellowship and mutual understanding.

5. To provide for the worship, practice, teaching and open discussion of the Christian religion.

6. To encourage its members to serve their community without personal financial reward.

ARTICLE V - MEMBERSHIP

Any person of legal majority and good moral character and good reputation in his or her community, may be granted membership in the corporation. Qualification for membership and manner of admission shall be governed and controlled as provided in the Constitution and By-Laws of the corporation and is by invitation only.

ARTICLE VI - REGISTERED AGENT

The street address of the initial registered office of the corporation is 3953B South Nova Road, Port Orange, Florida 32119 and the name of the initial registered agent of the corporation at such address is WAGID F. GUIRGIS.

ARTICLE VII - MANAGEMENT OF CORPORATE AFFAIRS

A. Board of Directors. All corporate powers shall be exercised by or under the authority of and the affairs of the corporation managed under the direction of its Board of Directors, consisting of not less than three (3) but not greater than seven

(7) persons, who must be members of the corporation, provided that such number may be changed by a By-Law duly adopted by the members.

The Directors named herein as the First Board of Directors shall hold office until the second annual meeting of members at which time an election of Directors shall be held. Directors elected at the second annual meeting, and at all times thereafter, shall serve for a term of two (2) years until the next second annual meeting of members following the election for Directors and until the qualification of the successors in office. The annual meeting shall be held in Daytona Beach Shores, Florida, on the first Sunday in August of each year, or at such other place or places as the Board of Directors may designate from time to time by resolution.

B. Corporate Officers. The Board of Directors shall elect the following officers: President, Vice-President, Secretary and Treasurer, and such other officers as the By-Laws of this corporation may authorize the Directors to elect from time to time. Initially, such officers shall be elected at the second annual meeting of the Board of Directors. Until such election is held,

the following persons shall serve as corporate officers:

President:	WAGID FAHIM GUIRGIS
Vice-President:	MOFID WAHBY
Treasurer:	WAGIS FAHIM GUIRGIS
Secretary:	ADEL DEMETRIOS

ARTICLE VIII - EARNINGS AND ACTIVITIES OF THE CORPORATION

A. No part of the net earnings, income or receipts of this corporation shall ever inure to the benefit of or be distributed to any officer, director, individual, member, or members of this corporation, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distribution in furtherance of the purposes set forth in Article IV hereof.

B. No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in or intervene in (including the publishing or distribution of statements) any political campaign on behalf of any candidate for public office.

C. Notwithstanding any other provision of these articles, the corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from Federal income tax under section 501 (c)(3) of the Internal Revenue Code of 1954 (or the corresponding provisions of any future United States Internal Revenue Law) or (b) by a corporation, contributions to which are deductible under section 170 (c)(2) of the Internal

Revenue code of 1954 (or the corresponding provision of any future United States Internal Revenue Law).

ARTICLE IX - INCORPORATOR

The name and address of the incorporator to the Articles of Incorporation is:

ARTICLE X - DISTRIBUTION OF ASSETS

Upon dissolution of the corporation, the Board of Directors shall, after paying or making provision for the payment of all the liabilities of the corporation, dispose of all of the assets of the corporation for the purposes of the corporation in such manner, or to such organization or organizations organized and operated exclusively for similar purposes as shall qualify as an exempt organization under Section 501 (c) (3) of the Internal Revenue Code as the Board of Directors shall determine. Any such assets not so disposed shall be disposed of by a Court of competent jurisdiction in the county in which the principal office is then located.

ARTICLE - XI DEDICATION OF ASSETS

The property of this corporation is irrevocably dedicated to religious, educational, charitable purposes, and no part of the net income or assets of this corporation shall ever inure to the benefit of any director, officer or member thereof, or to the benefit of any private individual.

ARTICLE XII - AMENDMENTS

These Articles of Incorporation may be amended as set forth in the By-Laws of this corporation.


