**ARTICLES OF AMENDMENT TO ARTICLES OF INCORPORATION OF**

We, the undersigned, being the President and Secretary of The Arabic Evangelical Church of Daytona Beach, Inc., a Florida not-for-profit corporation pursuant to Chapter 617, Florida Statutes, hereby certify that the following amendment to the Articles of Incorporation was adopted by Resolution of the Board of Directors at a Special Meeting held on April 18, 2001, and by the Members at a Special Meeting held on April 18, 2001, and there were present at such meeting and voting in favor of the amendments, 3 members of the total of 5 members, constituting sufficient number for approval of said amendments in accordance with Article XII of the Articles of Incorporation.

**AMENDMENT TO ARTICLE I**

In all other respects, the Articles of Incorporation shall remain as they were prior to the effective date of these Articles of Amendment.


