ARTICLES OF INCORPORATION

TARTARUGA TRAINING AND EDUCATION CENTER, INC.

ARTICLE I

The name of this corporation is the **Tartaruga Training and Education Center, Inc.**

ARTICLE II

The address of the corporation's registered office is Rt. 2, Box 121K, Greenville, Florida 32331. The name of its registered agent is Hines F. Boyd. The principal address is the same.

ARTICLE III

The **purpose of the corporation** is to engage in education and research and in other non-profitable activities which qualify as such within the meaning of Section 501(c)(7) of the Internal Revenue Code of 1986, as amended, or corresponding provision of any future United States Internal Revenue law (the "Code").

ARTICLE IV

The corporation is formed exclusively for purposes under which a corporation may be formed under the **non-profit corporation law** and not for pecuniary profit or financial gain. No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to its trustees, officers or other private persons or organizations, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered, and to make payments and distributions in furtherance of the purposes set forth in Article III hereof. The corporation shall have the power, either directly or indirectly, either alone or in conjunction or in cooperation with others, to do any and all lawful acts and things and to engage in any and all lawful activities which may be necessary, useful, suitable, desirable or proper for the furtherance, accomplishment, or attainment of any or all of the purposes for which the corporation is organized, and to aid or assist other organizations whose activities are such as to further, accomplish, foster or attain any such purpose. Notwithstanding any other provision hereof, the corporation shall not carry on any other activities not permitted to be carried on by a corporation exempt from federal income tax as an organization described in Code Section 501(c)(7).

ARTICLE V

Upon the dissolution of the corporation, the Trustees shall, after paying or making provision for the payment of all of the liabilities of the corporation, transfer, convey and distribute all of the assets of the corporation to a non-profit corporation affiliated with the University System of Florida or any of its member institutions. Such corporation must be exempt from federal income tax as an organization described in Code Section 501(c)(7) or 501(c)(3).

ARTICLE VI

The Board of Trustees shall consist of at least four but no more than thirty members, who shall constitute voting members of the organizations. Other voting and non-voting members of the corporation may be defined in the By-Laws.

ARTICLE VII

At the annual meeting, called in accordance with the Bylaws of the corporation, an election shall be held to elect the Trustees, except as provided otherwise in the Bylaws of the corporation. Each voting member shall have one vote, and the members present shall constitute a quorum. The candidates receiving the greatest number of votes shall be elected as Trustees.

ARTICLE IX


These Article of Incorporation may be amended by the affirmative vote of not less than a majority of the persons who exercise the voting rights of the corporation in accordance with its Bylaws.


