The undersigned subscriber to these Articles of Incorporation is a natural person competent to contract and hereby form a non profit Corporation under Chapter 617 of the Florida Statutes.

ARTICLE 1 - NAME

The name of the Corporation is **SAFE HAVEN ANGELS WATCHING OVER ME DAYCARE, INC.**, (hereinafter, "Corporation").

ARTICLE 2 - PURPOSE OF CORPORATION

The Corporation shall engage in any activity or business permitted under the laws of the United States and of the State of Florida mainly daycare center.

ARTICLE 3 - PRINCIPAL OFFICE

ARTICLE 13 - EFFECTIVE DATE


These Articles of Incorporation shall be effective on January 2, 1998.


