The undersigned, acting as incorporator(s) of a corporation pursuant to Chapter 617, Florida Statutes, adopt(s) the following Articles of Incorporation:

ARTICLE I

Name

The name of the corporation shall be:

Purpose(s)

The specific purpose(s) for which the corporation is organized is (are):

This corporation is organized to provide day care services for children ages one year old through four years old. The Purposes for which the corporation is organized are exclusively religious, charitable, scientific, literary and educational within the meaning of section 501(c)(3) of the Internal Revenue Code of 1986 or the corresponding provision of any future U.S. Internal Revenue law.

ARTICLE IV

Manner of election of directors

The manner in which the directors are elected or appointed is as follows:

The directors are elected by the members and officers of Love of Christ A. M. E. Zion Tabern, Inc., which owns and operates the Center, which may be as stated in the By-Laws.

ARTICLE V

Limitation of corporate powers

The corporate powers of this corporation are as provided in section 617.0302, Florida Statutes, unless limited as follows: Notwithstanding any other provision of these articles, this organization shall not carry on any activities not permitted to be carried on by an organization exempt from Federal income tax under section 501(c)(3) of the Internal Revenue Code of 1986 or the corresponding provision of any future United States Internal Revenue law.

The corporation will be subordinate to and subject to the authority of the Love of Christ A.M.E. Zion Tabernacle, Inc.

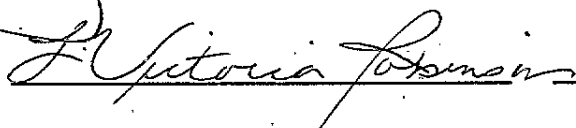

Addendum To Articles of Incorporation, p. 42

- VII. 5. Upon dissolution of the organization, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code of 1986, or corresponding section of any future Federal tax code, or shall be distributed to the Federal, state, or local government for a public purpose. Any such assets not so disposed of shall be disposed of by a Court of competent jurisdiction, of the county in which the principal office of the organization is then located, exclusively for such purposes.
