ARTICLES OF INCORPORATION

IRANIAN HERITAGE FOUNDATION, INC.

(A Florida Not for Profit Corporation)

The undersigned, being desirous of forming a corporation not for profit, but for civic, social, charitable and philanthropic purposes under the provisions of Chapter 617 of the Florida Statutes, does agree to the following:

ARTICLE I. NAME

The name of this corporation is:

IRANIAN HERITAGE FOUNDATION, INC.

ARTICLE II. PURPOSES

The purpose of the Foundation is to promote better understanding of the cultural heritage of the civilization of Iran, through education, including but not limited to exposure of America to Iranian art, literature, philosophy and other cultural activities. The Foundation is to be qualified under Section 501(c)(3) of the United States Internal Revue Code, as a charitable organization.

The purposes for which the Corporation is organized are exclusively charitable, scientific, literary or educational, within the meaning of Section 501(c)(3) of the United States Internal Revenue Code of 1986 or the corresponding provision of any future federal internal revenue law. Notwithstanding any other provision of these articles, this corporation shall not carry on any activity not permitted to be carried on by an organization exempt from federal income taxes under Section 501(c)(3) of the Internal Revenue Code of 1986 or the corresponding provision of any future federal internal revenue law.

ARTICLE III. MANAGEMENT OF CORPORATE AFFAIRS

This Corporation shall have no voting members. Its affairs shall be managed by a Board of Directors, the number and method of election of which shall be as set forth in the By-laws of the Corporation. The name and address of the initial board of directors is set forth hereinbelow.

ARTICLE IV. TERM OF EXISTENCE/DISTRIBUTION OF ASSETS UPON DISSOLUTION

Unless dissolved by the Board of Directors, this foundation is to exist perpetually. It is intended that this foundation qualify for exemption from United States Income Tax under Section 501(c)(3) of the United States Income Tax Code. Upon dissolution of this foundation for any reason, no director shall be entitled to receive, either directly or indirectly, any distribution or division of its remaining property or its proceeds. The balance of all money and other property received by the Foundation from any source after the payment of all expenses of winding up the business of the foundation, and the debts and obligations of the Foundation, shall be used or distributed to other organizations which are themselves exempt organizations under said Section 501(c)(3) or Section 170(c)(2) of the Internal Revenue Code of 1986 or corresponding section of any prior or future internal revenue code, or to the federal government, or to a state or local government for public purposes related to cultural activities.

ARTICLE VI. BOARD OF DIRECTORS.

Section 1. The business affairs of this Foundation shall be managed by a Board of Directors. The number of directors may be increased from time to time by the By-Laws. The Board of Directors shall be elected or appointed and hold office in accordance with the By-Laws.

ARTICLE VII. BY-LAWS

The By-Laws may be adopted or amended by a majority vote of the Board of Directors of the Foundation, a quorum being present, at any regular meeting or special meeting of the Board of Directors of the foundation.

ARTICLE VIII. AMENDMENTS

Section 1. Any proposed amendment to these articles of incorporation shall be submitted in writing and read to the Board of Directors at a regular meeting, or a special meeting called for that purpose, preceding the meeting at which the action on the amendment is to be taken.

Section 2. These articles of incorporation may be amended by a majority vote, a quorum being present, at a regular meeting or special meeting of the Board of Directors of the foundation, provided, however, that the conditions of Section 1 of this Article have been adhered to.

ARTICLE IX. LOCATION

The principal office of this corporation shall be located at 880 Riverside Drive, Ormond Beach, Florida, 32176, and shall be changed from time to time as provided for in the By-Laws. The initial mailing address shall be 880 Riverside Drive, Ormond Beach, Florida, 32176.

ARTICLE X. POWERS

In order to promote the purposes of this corporation, it may acquire property by grant, gift, purchase, devise or bequeath and hold and dispose of such property as the corporation shall require for the purpose for which the Foundation was formed, and not for pecuniary profit. For such purposes, the Foundation may exercise all such corporate powers as accrue under the laws of the State of Florida to not for profit corporations.
