ARTICLE I

The name of this corporation is **CHURCH OF GOD SEEKER OF SOULS, INC.**, A FLORIDA NOT FOR PROFIT CORPORATION.

ARTICLE II

The term for which this corporation shall exist, shall be perpetual.

ARTICLE III

The general nature of the business or businesses to be transacted by said corporation shall be as follows:

To foster, support, and engage in activities relative to religious concepts, goals, and ideals, including any and all activities which are lawful and appropriate in accordance with the tenets of Christianity and the laws of the laws of the State of Florida. The church shall engage in activities and programs that serve its congregation and the community at large, and which serve to promote religion, human development, mutual understanding, and public service.

That of engaging in any activity permitted under the laws of the United States of America, its territories, districts, and possessions, and any activity permitted under the laws of the State of Florida, and to have, exercise, and enjoy the powers and privileges granted to corporations not for profit by Chapter 617, Florida Statutes.

To do all and everything necessary, suitable, and proper for the accomplishment of any of the purposes, of the attainment of any of the objects, or for the furtherance of the powers herein set forth, either alone or in association with other corporations, firms, or individuals, and to do every other act or acts, thing or things, incidental or appurtenant ro or growing out of or connected with the aforesaid business of powers, or any part thereof; provided, that the same be not inconsistent with the laws under which this corporation is organized.
