ARTICLES OF INCORPORATION OF GLENWOOD HOMEOWNERS ASSOCIATION, INC.

I.

The Name of the corporation shall be GLENWOOD HOMEOWNERS ASSOCIATION, INC.

II

The duration of the corporation shall be perpetual.

III

The purpose for which the corporation is organized is to provide for the preservation of the values, amenities, attractiveness and desirability of real property known as Glenwood located in Leon County Florida.

V
