# ARTICLE I NAME OF CORPORATION "THE BROKEN TEE AMATEUR GOLFERS ASSOCIATION", INC.

#### ARTICLE II PURPOSE

#### ARTICLE X BYLAWS

The By-Laws of the corporation are to be made, altered or rescinded by the majority of the members voting. Any By-Law may be amended or otherwise changed providing a member submits a written request to the Board of Directors. The President is then required to have the amendment read at three (3) consecutive meetings. A vote will be entertained at the fourth (4<sup>th</sup>) meeting. The By-Law may then be changed by a majority of the members voting.

The method of election of directors is as stated in the bylaws.

#### ARTICLE XI

The Articles of Incorporation of the corporation are to be altered, amended, repealed or added to by a three-fifths majority of the members voting. Any article may be amended or otherwise changed providing a member submits a written request to the Board of Directors. The president is then required to have the amendment and/or article read at (3) three consecutive meetings. A vote will be entertained at the fourth (4th) meeting. The article may then be changed by a threefifths majority of the members voting.
