ARTICLES OF INCORPORATION OF "ITALIAN FUND, INC."

A FLORIDA NONPROFIT CORPORATION

ARTICLE I. NAME. The name of the Corporation is: ITALIAN FUND, INC.

ARTICLE II. PRINCIPAL OFFICE. The principal place of business and mailing address of this corporation shall be: 4100 NE 2nd Avenue, Suite 210, Miami, Florida 33137.

ARTICLE III. PURPOSE. This Corporation is a non-for-profit Corporation organized under Chapter 617, Florida Statutes. It is not organized for the private gain of any person. The specific purposes of this corporation are:
