The undersigned, acting as the incorporator of a corporation pursuant to Chapter 617, Florida Statutes, adopts the following articles of incorporation.

ARTICLE 1- NAME

The name of the corporation shall be: SOMEBODY CARES, CAPE CANAVERAL , INC.

ARTICLE II- PRINCIPAL PLACE OF BUSINESS AND MAILING ADDRESS:

The principal place of business and the mailing address of this corporation shall be:

310 LINDSEY COURT, CAPE CANAVERAL FL 32920

ARTICLE III-PURPOSE

The specific purposes for which the corporation is organized are for:

The CONDUCTING OF SIDEWALK SUNDAY SCHOOL IN FLORIDA, and in particular in the County of Brevard and Cape Canaveral, Florida. It shall be able to do all other matters of a Christian Nature in the Field of Christian Education as well as any other Christian Endeavors.

It shall have the authority permitted for not for profit organizations to engage in any or all lawful activities permitted under the laws of the United States of America, the State of Florida, or any other State, Country, Territory or Nation.

ARTICLE IV- MANNER OF ELECTION OF DIRECTORS:

The affairs of the Corporation shall be managed by a Board of Directors. The Board shall have the power to admit members to the corporation in such manner, subject to such qualifications, and upon such terms and with such rights as may be provided from time to time by By-Laws of the corporation.

ARTICLE V-LIMITATION OF CORPORATE POWERS:

The corporate powers of this corporation are as provided in section 617.0302, Florida Statutes.

ARTICLE VIII-DISSOLUTION

UPON DISSOLUTION OF THE CORPORATION, THE BOARD OF DIRECTORS SHALL, AFTER PAYING OR MAKING PROVISIONS FOR THE PAYMENT OF ALL THE LIABILITIES OF THE CORPORATION, DISPOSE OF ALL THE ASSETS OF THE CORPORATION TO ANOTHER ORGANIZATION OR ORGANIZATIONS WHICH ARE ORGANIZED AND OPERATED FOR THE SAME PURPOSES FOR WHICH THIS CORPORATION IS ORGANIZED OR TO SUCH ORGANIZATION OR ORGANIZATIONS ORGANIZED AND OPERATED EXCLUSIVELY FOR CHARTITABLE, EDUCATIONAL, RELIGIOUS, LITERACY, OR SCIENTIFIC PURPOSE AS SHALL AT THE TIME QUALIFY AS AN EXEMPT ORGANIZATION OR ORGANIZATIONS UNDER SECTION 501C3 OF INTERNAL REVENUE CODE OF 1954 AS AMENDED, AS THE BOARD OF DIRECTORS SHALL DETERMINE. ANY SUCH ASSETS NOT SO DISPOSED OF SHALL BE DISPOSED OF BY THE CIRCUIT

COURT OF THE COUNTY IN WHICH THE PRINCIPAL OFFICE OF THE CORPORATION IS THEN LOCATED, EXCLUSIVELY FOR SUCH PURPOSES OR TO SUCH ORGANIZATION OR ORGANIZATIONS, AS SAID COURT SHALL DETERMINE, WHICH ARE ORGANIZED AND OPERATED EXCLUSIVELY FOR SUCH PURPOSES.

ARTICLE IX

THE MEMBERS OF THIS CORPORATION SHALL HAVE NO RIGHTS, TITLE OR INTEREST WHATSOEVER IN ITS INCOME, PROPERTY, OR ASSETS, NOR SHALL ANY PORTION OF SUCH INCOME, PROPERTY, OR ASSETS BE DISTRIBUTED TO ANY MEMBER ON THE DISSOLUTION OR WINDING UP OF THIS CORPORATION. MEMBERS OF THIS CORPORATION SHALL NOT BE PERSONALLY LIABLE FOR THE DEBTS, LIABILITIES OR OBLIGATIONS OF THE CORPORATION AND SHALL NOT BE SUBJECT TO ANY ASSESSMENTS.
