The undersigned incorporator, for the purpose of forming a corporation under the Florida Not for Profit Corporation Act, hereby adopts the following Articles of Incorporation:

Article I - Corporate Name

The name of this corporation shall be Dixie Matches Inc.

Article II - Principal Office

The principal place of business and mailing address of this corporation shall be:

Jacksonville, Florida 32256.

Article III - Purposes

The purposes of this corporation are:

- (a) To encourage organized rifle and pistol shooting, with emphasis on competitive shooting, among citizens of the United States with a view toward a better knowledge on the part of such citizens of the safe handling and proper care of firearms, as well as improved marksmanship.
- (b) To forward the development of these characteristics of honesty, good fellowship, self-discipline, team play and self-reliance which are essentials of good sportsmanship and the foundation of true patriotism.

Article IV - Election of Directors

Article VII - Duration

Existence of this corporation shall commence with the filing of these Articles of Incorporation with the Secretary of State, Tallahassee, Florida. The corporation shall exist in perpetuity.

Article VIII - Changing of Bylaws

The bylaws of the corporation may be made, altered, or rescinded at any annual meeting of the corporation, or at any special meeting duly called for such purpose, on the affirmative vote of two-thirds of the members existing at the time of and present at such meeting except that the initial bylaws of the corporation shall be made and adopted by the board of directors.

Article IX - Amending Articles of Incorporation

Amendments to these Articles of Incorporation may be proposed by any member of the corporation. These Articles may be amended at any annual meeting of the corporation, or at any special meeting duly called and held for such purpose, on the affirmative vote of two-thirds of the members existing at the time of, and present at such meeting.

Article X - Indemnification

Every director and every officer of the corporation shall be indemnified by the corporation against all expenses and liabilities, including attorney's fees, reasonably incurred by or imposed upon him in connection with any proceedings to which he may be a party, or in which he may become involved, by reasons of his being or having been a director or officer of the corporation, whether or not he is a director or officer at the time such expenses are incurred, except in such cases wherein the director or officer is adjudged guilty of willful misfeasance or malfeasance in the performance of his duties. The foregoing right of indemnification shall be in addition to and not exclusive of all other rights to which such director or officer may be entitled.
