ARTICLES OF INCORPORATION OF

UNITED 7th DAY CHURCH OF GOD, INC.

(Affiliated with Seventh Day Church of God, of Florida, Sarasota, County)

ARTICLE I - NAME

The name of this Corporation is: **UNITED 7th DAY CHURCH OF GOD, INC.**

ARTICLE II - PURPOSE

The purposes for which the organization is organized are exclusively religious, charitable, scientific, literary, and educational within the meaning of section 501(c) 3 of the Internal Revenue Code of 1986 or the corresponding provision of any future United State of Internal Revenue Law.

This corporation is a NOT -FOR-PROFIT corporation and is not organized for the private gain of any person. It is organized under the nonprofit Public Benefit Corporation Law for charitable purposes.

ARTICLE III - SPECIFIC PURPOSES

- The specific purposes of this corporation are: (1). To cultivate, promote and extend the teachings and practices of the Bible.
(2). To receive Tithe, Offerings, Gifts and Bequests in order to promote the purpose of the corporation.
(3). To exercise all rights and powers conferred by the laws of the State of Florida upon Non-Profit Corporations.

The initial Board of Directors will consist of seven (7) directors. The number of directors may be increased or decreased by amendment of the bylaws, but, shall in no case be less than three.

ARTICLE VI - ORGANIZATION

A. This Corporation is organized and operated exclusively for charitable purposes within the meaning of section 501 (c) 3 of the Internal Revenue Code.

B. Notwithstanding any other provision of these Articles, this organization shall not carry on any activities not permitted to be carried on by an organization exempt from Federal Income tax under section 501 (c) 3 of the Internal Revenue Code of 1986 or the corresponding provision of any future United States Internal Revenue Law.

C. No substantial part of the activities of this corporation shall consist of carrying on propaganda, or otherwise attempting to influence legislation, intervene in any political campaign on behalf of any candidate for public office.

ARTICLE VII - STOCK

This Corporation is organized (and shall be operated) on a non-stock basis within the meaning of the **Florida Not For Profit Corporation Act**, and shall not have the power to issue shares of any type or class of stock, but, may issue membership cards or certificates if so provided in the bylaws.

ARTICLE VIII - OFFICERS

The Officers of the Corporation shall consist of a President, Vice President, Secretary and Treasurer. Each shall be elected by the Board of Directors and may be removed by the Board, at such time and in such manner as may be prescribed in the bylaws.

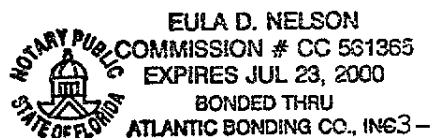
