AMENDMENTS TO THE ARTICLES OF INCORPORATION  
OF NEW HOPE CHRISTIAN CHURCH OF ARCADIA INC.

Purposes:

Original Stated Purpose (Corrected):

NEW HOPE CHRISTIAN CHURCH OF ARCADIA INC. was organized as a religious and charitable organization to (see Article 1-Section B in By-Laws) and as resources allow, to provide monetary contributions to Bible Colleges, Christian Service Camps and other worthy Home and Foreign Missions.

Amendment To Original Purpose:

Having been organized as a purely religious and charitable organization for the purpose of worshipping God and presenting His word to our community, NEW HOPE CHRISTIAN CHURCH OF ARCADIA INC. will be involved only in strictly Religious/Charitable activities and will at no time become involved in political or propaganda activities for legislative purposes. The organization will not endorse or campaign for any candidate for public office. All members will be free to exercise their constitutional rights as private citizens but not a representative of this organization.

As resources permit, we will provide financial support to Florida Christian College in Kissimmee, Florida and Lake Aurora Christian assembly in Lake Wales, Florida and other home or foreign missions as deemed appropriate by our members. In the event of dissolution of our organization, any remaining assets will be distributed to the above named college and Christian Assembly (Service Camp). If they are neither one still in existence then to another recognized tax exempt organization under Section 501 C 3 of Internal Revenue Code at that time.

Members, Officers, Trustees or private individuals are not to receive any monies from the organization unless it is for reimbursement of expenses, and then only with a receipt for money spent on behalf of the organization. The only people to receive money from the organization otherwise would be the Minister and/or salaried staff and business or service agencies for services provided.
