HERITAGE MANOR OF MEMORIAL PARK, INC.

The undersigned subscribers to the Articles of Incorporation, each a natural person, competent to contract, hereby associate themselves together to form a not for profit corporation under the laws of the State of Florida.

ARTICLE I. NAME

The name of the not for profit corporation is HERITAGE MANOR OF MEMORIAL PARK, INC.

ARTICLE II. NATURE OF BUSINESS

This not for profit corporation will conduct business as a Mausoleum Cemetery for the purpose of the internment of deceased persons and for no other purposes.

This not for profit corporation may engage or transact in any or all lawful activities or business permitted under the laws of the United States, the State of Florida or any other state, country, territory or nation for a not for profit corporation incident to such purposes of the corporation as a cemetery. No part of the assets, income, or profit of the corporation shall be distributable to, or inure to the benefit of, its members, directors, or officers, except for reasonable compensation for services rendered or to the extent

permitted under Florida law. The corporation shall never be operated for the primary purpose of carrying on a trade or business for profit.

ARTICLE III. INITIAL CAPITAL

The amount of capital with which this not for profit corporation will begin business is not less than One Thousand Dollars (\$1,000.00).

ARTICLE IV. SPECIAL PROVISION

This not for profit corporation is intended to qualify under the requirements of Section 501 (C) 13 of the Internal Revenue Code and the regulations issued thereunder.

This not for profit corporation will abide by all the laws, rules and regulations of the State of Florida Comptrollers Office, Bureau of Funeral and Cemetery Services.

Such actions as are necessary will be taken by the directors to accomplish these compliances.

ARTICLE V. TERM OF EXISTENCE

This not for profit corporation shall exist perpetually.

ARTICLE VI. ADDRESS

The initial post office address of the registered agent, registered office and mailing address of this not for profit corporation in the State of Florida is:

The Board of Directors may, from time to time, move the principal office to any other address.

ARTICLE VII. DIRECTORS

This not for profit corporation shall have four Directors, initially. The number of Directors may be increased or diminished from time to time by By-Laws adopted by the stockholders, but shall never be less than three. Directors shall be elected annually by the stockholders of the corporation.

ARTICLE IX. AMENDMENT

The Articles of Incorporation may be amended in the manner provided by law. Every amendment shall be approved by the Board of Directors, proposed by them to the stockholders, and approved at a stockholders meeting by a majority of the stock entitled to vote thereon, unless all the Directors and all the stockholders sign a written

statement manifesting their intention that a certain Amendment of the Articles of Incorporation be made.

ARTICLE X. DISSOLUTION

In the event of the liquidation or dissolution of the corporation, whether voluntary to involuntary, no stockholder shall be entitled to any distribution or division of the property or proceeds. The balance of all money and other property which the corporation received from any source, after the payment of all debts and obligations of the corporation, shall be used or distributed exclusively for purposes within those set forth in Article II of these Articles of Incorporation and within the purposes of Section 501 (C) of the Internal Revenue Code of 1986 and Regulations thereunder as the same now exist or as they may hereafter be amended from time to time.
