ARTICLES OF INCORPORATION

FOR

OSCEOLA COUNTY DOMESTIC VIOLENCE TASK FORCE, INC.

The undersigned, acting as incorporator(s) of a corporation pursuant to chapter 617, Florida Statutes, adopt(s) the following Articles of Incorporation for this nonprofit corporation:

ARTICLE I: NAME

The name of the corporation shall be:

OSCEOLA COUNTY DOMESTIC VIOLENCE TASK FORCE, INC.

ARTICLE II: PRINCIPAL PLACE OF BUSINESS AND MAILING ADDRESS

The principal place of business and the mailing address of this corporation shall be:

ARTICLE III: DURATION

The duration of the corporation is perpetual unless dissolved according to the law.

ARTICLE IV: PURPOSE(S)

The specific purpose(s) for which the corporation is organized is (are):

This task force is dedicated to ensuring a comprehensive, coordinated community response to domestic violence issues and policies in Osceola County, Florida, including but not limited to:

- Promoting the provision of adequate support services & programs for victims of domestic violence & their families;

- The enforcement of remedial & educational programs for perpetrators of domestic violence;

- The promotion of on-going training and education for all Osceola County Agencies and their staff who deal with domestic violence issues;

- Increasing public awareness of the impact of domestic violence on all sectors of the community.

ARTICLE V: MANNER OF ELECTION OF DIRECTORS

The manner in which the directors are elected or appointed is as follows: The manner by which Directors are elected and appointed shall be as provided in the By Laws.

ARTICLE VI: NON-STOCK BASIS

The corporation is organized (and shall be operated) on a non-stock basis within the meaning of the Florida Not for Profit Corporation Act, and shall not have the power to issue shares of any type or class of stock, but may membership certificates if so provided in the Bylaws.

ARTICLE VII: DISSOLUTION

A. In the event, of dissolution, all of the remaining assets and property of the corporation shall after necessary expenses thereof be distributed to such organization as shall qualify under Section 501(c) (3) of the Internal Revenue Code of 1954, as amended, or to another organization to be used in such manner as in the judgment of a Judge of the Circuit Court of the State of Florida will best accomplish the general purposes for which this corporation was formed.

B. Notwithstanding any other provision of these articles, the corporation is organized exclusively for one or more of the following purpose: religious, charitable, civic, cultural, scientific testing for public safety, literary or educational purpose or to foster national or international amateur sports competition (but only if no part of it's activities involve the provision of cruelty to children or animals, as specified to in Section 501(c) (3) of the Internal Revenue Code of 1954, and shall not carry on any activities not permitted to be carried on by a corporation exempted from Federal Income Tax under Section 501(c) 3) of the Internal Revenue Code of 1954.

C. No part of the net earnings of the corporation shall inure to the benefit of any member, trustee, director, officer of the corporation or any private individual (except that reasonable compensation that may be paid for services rendered to or for the corporation) and no member, trustee, officer of the corporation or any private individual shall be entitled to share in the distribution of any of the corporate assets on dissolution of the corporation.

ARTICLE VIII: LIMITATION OF CORPORATE POWERS

The corporate powers of this corporation are as provided on Section 617.0302. Florida Statutes, unless otherwise limited:

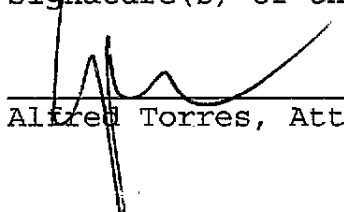
