
**ARTICLES OF DISSOLUTION

5. In accordance with XII of the Articles of Incorporation of the Corporation, all remaining assets shall be distributed to His Image Ministries, Inc., 1557 Cesery Blvd., Jacksonville, Florida 32211, which is an organization organized and operated exclusively for charitable, educational, religious or scientific purposes and which is qualified as an exempt organization under Section 501(c)(3) of the Internal Revenue Code of 1986, as amended.
