**ARTICLES OF INCORPORATION
OF
THE ALPHA CLUB, INC.**

The undersigned incorporators of a corporation pursuant to chapter 617, Florida Statutes, adopt(s) the following Articles of Incorporation.

ARTICLE I: Name

The name of the corporation is The Alpha Club, Inc.

ARTICLE II: PRINCIPAL OFFICE ADDRESS

The principal office of the corporation shall be located at 4418B North Hubert Street, Tampa, Florida 33614 and the mailing address of the corporation shall be 4418B North Hubert Street, Tampa, Florida 33614.

ARTICLE III: PURPOSE

The corporation is organized as a social club as described in Internal Revenue Code Section 501^c(7). The club is organized to provide social and recreational activities for its members in an alcohol and drug free environment.

ARTICLE IV: MANNER OF ELECTION OF DIRECTORS

The incorporators shall serve as directors for the first year of incorporation. Thereafter there shall be a meeting of all members on or about the anniversary of the date of incorporation. The directors and officers will be elected to a term of office of one year from the date of the annual membership meeting.

Any or all officers or directors may be removed from office for just cause, as directed in the By-laws, by majority vote of the members present at the annual membership meeting or at any special membership meeting called by a quorum of the membership for the purpose of the replacement of the officer, officers and/or director or directors as will be provided for in the By-laws of the corporation.

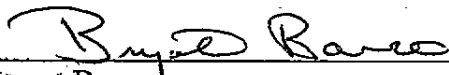
