ARTICLES OF INCORPORATION

The undersigned incorporator, for the purpose of a corporation under the Florida Not for Profit Corporation Act, hereby' adopts the following Articles of Incorporation.

ARTICLE I NAME

The name of the: corporation shall be:

ARTICLE III PURPOSES

The specific purposes for which the corporation is organized are:

The objectives of this Church shall be:

1. To make disciples of Jesus Christ, baptize them, and to Teach them the Word of God, as we see and understand it.
2. To provide for a place of worship.
3. To receive, hold, and disburse gifts, bequests, devises, and other funds for these purposes.
4. To own and maintain or to lease suitable real estate and buildings, and any other personal property which is deemed necessary for it's Purposes,
5. To enter into, make, and perform, and carry out: contracts that are for any lawful purpose, without limit as to amount.

The purpose of this church shall be the carrying out of the Great Commission and other such ministries as are specified in the Scripture for a New Testament Church. The Great Commission, as given by Jesus Christ in Matthew 28:18-20, is the evangelism of the lost, bringing them to identification with Christ's church through baptism, and teaching them to observe all things commanded by God.

ARTICLES OF INCORPORATION

ARTICLE IV MANNER OF ELECTION OF DIRECTORS

The manner in which the directors are elected or appointed is:

Trustees: The Trustees shall have no authority independent of the membership of the Church. Principal function is to act as signatories to contracts, documents and agreements as directed and authorized by the membership. The trustees shall be elected from the membership for six year terms. They will hold in trust the church property and serve as a financial committee. They have no power to buy, sell, mortgage, lease, or transfer any property without a specific vote of the church authorizing each action. They shall sign legal papers as needed and directed by the church. **The manner in which Trustees shall be elected shall be according to the Bylaws.**

The Church shall have not less than three (3) and no more than ten (10) Trustees.

The Trustees of this Church shall be regular members of this Church who have a desire to serve their church.

The membership may declare a vacancy in the office of a Trustee on the occurrence of any of the following events:

1. The Trustee has been declared of unsound mind by a final order of court;
2. The Trustee has been convicted of a felony.
3. Disciplinary action has been taken against him by the Church.

The need for the election of a Trustee shall exist on the death, resignation, or removal of any Trustee; whenever the number of Trustees authorized is increased; and on the failure of the membership in any election to elect the full number of Trustees authorized, although the required number of Trustees may thereafter be filled by a majority of the general membership at the noticed business meeting.
