**ARTICLES OF INCORPORATION**

The undersigned incorporator by these Articles associates for the purpose of forming a corporation not for profit pursuant to the laws of the State of Florida, and adopts the following Articles of Incorporation:

**ARTICLE I**

**NAME**

The name of the corporation is Everglades Region, Porsche Club of America, Inc.

**ARTICLE II**

**PRINCIPAL PLACE OF BUSINESS AND MAILING ADDRESS**

The principal place of business of the corporation is as follows:

**ARTICLE III**

**TERM OF EXISTENCE**

The association shall have perpetual existence, and the corporate existence will commence on the filing of these articles with the Department of State.

## ARTICLE IV

### PURPOSE

The purposes for which this corporation are formed are:

1. The highest standards of courtesy and safety on the roads.
2. The enjoyment and sharing of good will and fellowship engendered by owning a Porsche and engaging in such social and other events as may be agreeable to the membership.
3. The maintenance of the highest standards of operation and performance of the marque by sharing and exchanging technical and mechanical information.
4. The establishment and maintenance of mutually beneficial relationships with the Porsche works, Porsche dealers and other service sources to the end that the marque shall prosper and continue to enjoy its unique leadership and position in the automotive annals.
5. The interchange of ideas and suggestions with other Porsche clubs throughout the world and in such cooperation as may be desirable.
6. The establishment of mutually cooperative relationships with other sports car clubs as may be desirable.
7. Generally to have and exercise all rights and powers conferred on nonprofit corporations under the laws of the State of Florida, or which may hereafter be conferred, including the power to contract, rent, buy, or sell personal or real property.
8. Notwithstanding any of the above statements of purposes and powers, this corporation shall not, except to an insubstantial degree, engage in any activities or exercise any powers that are not in furtherance of the primary purpose of this corporation.

## ARTICLE V

### MEMBERS

The qualification of members and the manner of their admission shall be as regulated by the Bylaws.

**ARTICLE VI**

**DIRECTORS**

The qualification of the Directors and the manner of their election or appointment shall be as regulated by the Bylaws.

**ARTICLE VII**
