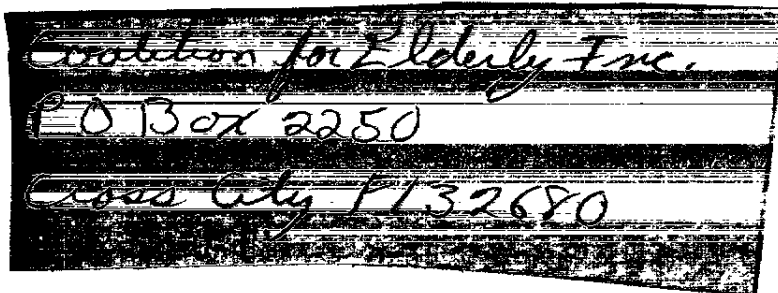

**Articles of Amendment  
of  
Tri County Coalition For The Elderly**

**A NOT FOR PROFIT ORGANIZATION**

**BY THESE ARTICLES OF INCORPORATION THE INCORPORATOR  
FORMS A CORPORATION UNDER FLORIDA LAW**

**ARTICLE I  
NAME**

The name of the corporation shall be **Tri-County Coalition For The Elderly Incorporated**. The Principal place of business of this corporation shall be:  
8511 N. W. 168 Place  
Trenton Florida 32693

**ARTICLE II  
NATURE OF BUSINESS**

This membership shall provide through a charitable manner, assistance to the elderly, with needs both met and unmet by introducing resources already available or developing new resources. The organization will assist to eliminate duplication of services.

**ARTICLE III  
MEMBERSHIP**

A. Membership procedures. This shall be a nonstock corporation. Membership in this organization shall be open to all persons, interested in furthering the goals of this coalition. Procedures, rules, and fees, for membership shall be set forth in the By Laws.

B. Adherence to Rules. All members shall agree to be bound by the Articles of Incorporation and By Laws of this organization.

C. Government. This organization shall be governed by it's Articles of Incorporation and By Laws.

D. Annual Meeting. The annual meeting shall be held at such time and place as specified in the By Laws. Notice under s.607.084 shall be given to all members.

**ARTICLE IV

**ARTICLE V  
TERM OF EXISTANCE**

The term of existence of the corporation shall be perpetual or until such time as it is dissolved as provided by laws of the State of Florida and shall commence upon filing of these Articles of Incorporation with the Secretary of State. Upon dissolution of this corporation all assets real or otherwise shall be turned over to the State of Florida to be distributed to another nonprofit organization of their choice.

**ARTICLE V AMENDMENT**

Sid organization is organized exclusively for charitable, religious, educational, and scientific purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501 (c) (3) of the Internal Revenue Code, or corresponding section of any future federal tax code.

No part of the net earnings of the organization shall emure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that the organization shall be authorized and empowered to pay reasonable compensation for the services rendered and to make payments and distributions in furtherance of the purposes set forth in the purpose clause hereof. No substantial part of the activities of the organization shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the organization shall not participate in, or intervene in ( including the publishing or distribution of statements) any political campaign on behalf of any candidate for public office. Notwithstanding any other provision of this document, the organization shall not carry on any other activities not permitted to be carried on (a) by an organization exempt from federal income tax under section 501 (c) (3) of the Internal Revenue Code, or (b) by an organization, contributions to which are deductible under section 170 (c) (2) of the internal Revenue Code, or corresponding section of any future federal tax code.

Upon the dissolution of the organization, assets shall be distributed for one or more exempt purposes within the meaning of section 501 (c) (3) of the Internal Revenue code, or corresponding section of any future federal tax code, or shall be distributed to the federal government, for a public purpose. Any such assets not disposed of shall be disposed of by the Court of Common Pleas of the county in which the principal office of the organization is then located, exclusively for such purposes or to such organizations or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.

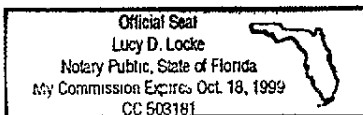
