ARTICLES OF INCORPORATION  
OF  
COCONUT CREEK HS COLOR GUARD PARENT ASSOCIATION, INC.

ARTICLE I

01-01-98

The name of this non-profit corporation is COCONUT CREEK HS COLOR GUARD PARENT ASSOCIATION, INC.

ARTICLE II

The principal address, and mailing address of the corporation is: 6981 N.W. 5<sup>th</sup> Court, Margate, Florida 33063.

ARTICLE III

The purpose for which this corporation is organized is:

To coordinate and govern the activities of the Coconut Creek High School Color Guard and Winter Guard team(s); to hire and pay instructors and staff members; to purchase equipment, supplies, insurance and any items necessary to the operation of the team(s) and the Association; to enter into contractual agreements; to collect dues and fees; to solicit and appropriate donations, grants, and community contributions; to join and hold membership in civic, trade, and special-interest groups and organizations; and to perform any and all activities in which corporations may legally engage under the laws of the State of Florida.

ARTICLE IV

The manner in which the Directors of the corporation are to be elected is as follows: Elections shall be made by majority vote of the Directors. This provision may be ratified by new laws adapted by the Board of Directors.

The number of directors constituting the initial board of directors is four (4), and the name and address of the person or persons who are to serve as directors until the first annual meeting of the shareholders or until their successors are elected and qualified are:

## ARTICLE V

The Corporate Powers shall not be limited. This Corporation shall have full exercise of all powers necessary to carry out the purposes and objectives of this corporation, as may be determined by the Board of Directors, in accordance with Section 617.0302, Florida Statutes.

The Board of Directors is empowered to make, alter or repeal the Bylaws of the corporation without restriction of their powers conferred by statue.

## ARTICLE VI

The street address of its initial registered office is 6981 N.W. 5<sup>th</sup> Court, Margate, Florida 33063, and the name of its initial registered agent at such address is Darlene Mages.

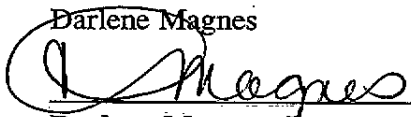
