ARTICLE OF INCORPORATION

OF

(A CORPORATION NOT FOR PROFIT)

We the under signed, hereby associate ourselves together for the purposes of becoming Incorporated under Chapter 617, Florida Statutes, applicable to corporation not for profit, and respectfully petition the Secretary of State for approval of such Incorporation under the proposed Articles of Incorporation.

ARTICLE I

The name of the Corporation shall be Trust and Joy to Help All Jesus Children International INC. A not for profit organization, And it's principle place of business shall be at 2231 9th Ave West, Bradenton, Florida 34205. The name of the registered agent at that address is Julia Morame.

ARTICLE II

PURPOSE

The general purpose of Trust and Joy to Help All Jesus Children International INC. A not for profit organization shall be to provide clothing, Food for Local and Goreign Children and for those who are in need.

ARTICLE III

MEMBERSHIP-

The membership of Trust and Joy to Help All Jesus Children International shall be open to all person who are desirous of assisting in the purpose for which Trust and Joy to Help All Children International INC is being formed as enumerated in Article II above when authorized by the Board of Directors.

ARTICLE IV

Terms of Existence

ARTICLE VI

Board of Directors

Section I. The business affairs of Trust and Joy to Help Children International INC. shall be managed by a governing board called the Board of Directors which shall consist of not less than Ten (10) nor more than twelve (12) directors as may be specifically determine by the by-laws of Trust and Joy to Help All Jesus Children International INC. The interest and the objective of Trust and Joy to Help All Jesus Children International INC. SHALL be under their directions and supervision and they shall have limited control as to administrative matters in the operation and activities of Trust and Joy to Help All Jesus Children International INC.

Section II. At least one third of the Board of Directors shall be made up of democratically elected representatives of the poor, that is the residents

Of the area and members of the group that the community action program is intended to serve; although representatives of the poor need not themselves be selected in a manner which insures that they represent the poor and are residents of the area they represent.

B. The Board should consist of members of business, Industry, Labor, Religious, Education significant minority group and other private group.

ARTICLE VII

OFFICERS

Section I. ARTICLE VIII

By-Laws

Section I. The Board of Directors of Trust and Joy to Help All Jesus Children International INC., shall have the right to make and adopt by-laws as they deem proper and advisable and such by-laws shall be made altered, or rescinded upon a two-third vote of the Board of Directors present and voting at any regular or special business meeting to the Board of Directors called for that purpose by the President as provided in the by-laws. By-Laws so prepared, altered, or rescinded shall be submitted to the membership at a regular or special meeting for their approval or refusal.

Section II. For these purposes a quorum shall consist of 1/2 of the members of the Board of Directors.

ARTICLE IX

Amendments of Article of Trust and Joy to Help All Jesus Children International INC.

Amendments to the article of Trust and Joy to Help All Jesus Children International INC., may be proposed at a regular or special business meeting of the Board and must be adopted by two-third vote of the Board of Directors, present and voting at such meeting properly called and notice given as provided by the by-laws and such amendment shall be

approved by a two-third (2/3) affirmative vote of the members present upon such approval such amendment must also be forwarded to the Secretary of State of Florida and filed and approved by him before the same become effective.

ARTICLE X

Powers

Trust and Joy to Help All Jesus Children International INC. is to have the power to do any and all things necessary or expedient for carrying out the purpose of Trust and Joy to Help All Jesus Children International INC and in general to possess all rights, privileges, and immunities, and enjoy all the benefits granted to Trust and Joy to Help All Jesus Children International INC., of similar character under the laws of the State of Florida, including but not limited to, the power to make and enter contracts receive and disburse funds franted by Federal, State or private agencies or organizations; make community studies, develop programs, conduct research and coordinate, supervise, and administer such programs and research projects as are necessary in the furtherance of its corporate purposes.

ARTICLE XI

Distribution of Assets Upon Dissolution

Upon dissolution of Trust and Joy to Help All Jesus Children International INC., all of its remaining assets after payment of all cost and expenses of such disolution shall be distributable to organizations which have qualified for exemption under 501 Section (c) (3) of the Internal Revenue Code or to the Federal Government or to the State or Local government for public purpose, and none of the assests shall be distribute to any member director, officer, or trustee of this organization.
