ARTICLES OF INCORPORATION
OF

ARTICLE I NAME

ARTICLE IV MANNER OF ELECTION OF DIRECTORS

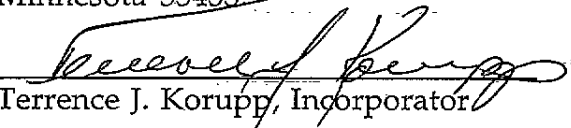
The manner in which the directors are elected or appointed shall be as set forth in the bylaws of the corporation.

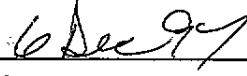

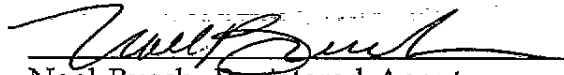

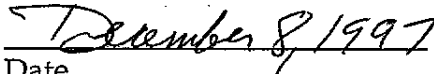
