#### ARTICLE I

The name and address of the Corporation shall be: DAY CARE AND CHILD DEVELOPMENTAL OF THE IGLESIA DEL NAZARENO DE WINTER PARK, INC. 1220 FORMOSA AVE., WINTER PARK, FLORIDA, 32789

#### ARTICLE II

The term of existence of the Corporation is: Perpetual.

# ARTICLE III

The purpose for which the Corporation is formed is to establish and maintain a day care and child developmental center. This corporation is subordinate to the Church of the Nazarene, Central Florida District, and the Iglesia del Nazareno de Winter Park, Inc.

For the accomplishment of these objects, the corporation shall have power to distribute books, magazine, papers and other literature as will further carry out the objects of this corporation; to acquire by the purchase or gifts such real and personal property as may be necessary to carry out the objects of this corporation and to receive subscriptions and donations of real and personal property to be applied to the uses and purposes of the corporation; to mortgage and otherwise encumber any of its property or to sell and convey the same; and to permit the use of its property for the religious, educational, benevolent or other lawful purposes.

There shall be ten (10) members of the initial Board of Directors of the corporation, wherefore, after the first election the Board of Director shall be compose of five (5) members. - B. Have declared their belief in the doctrines and teachings of the Church of the Nazarene.
- C. Shall declare their willingness to submit to the government of the Iglesia del Nazareno de Winter Park, Inc. and the Church of the Nazarene.

Persons meeting such qualifications will be admitted in the following manner:

- Prospective members shall receive an explanation of the privileges and responsibilities of membership in the Iglesia del Nazareno de Winter Park, Inc. and Church of the Nazarene, the Articles of Faith, the requirements of the general and special rules and the purpose and mission of the Church of the Nazarene by the Pastor.
- 2. Following such orientation, prospective members shall be considered by the Evangelism and Church Membership Committee.
- Upon favorable recommendation of the Evangelism and Church
  Committee, candidates shall be received as members of the Iglesia del
  Nazareno de Winter Park, Inc. by the Minister in a public service following
  the prescribed ceremony detailed in the Manual of the Church of the
