### ARTICLE I

#### Name

c) To engage in any lawful act or activity for which non-profit corporations may be organized under the general corporation law of the State of Florida.

d) To operate exclusively for such charitable and educational purposes as will qualify it as an exempt organization under Section 501 (c) (3) of the Internal Revenue Code 1954 or Corresponding provision of any subsequent Federal Tax Laws.

e) This corporation shall not as a substantial part of its activities, carry on propaganda or otherwise attempt to influence legislation; nor shall it participate or intervene (by publication or distribution of any statement or otherwise) in any political campaign on behalf of any candidate for public office.
