Articles of Incorporation
Gulf Coast History and Folklore Association, Inc.

Article I: The name of the corporation shall be GULF COAST HISTORY AND FOLKLORE ASSOCIATION INC.

Article II: The principal place of business and mailing address of this corporation is:
2086 Las Vegas Trail, Navarre, Fl 32566-7559

Article III: The specific purpose for which the corporation Gulf Coast History and Folklore Association Inc. is organized is to promote the knowledge of history, folklore, archaeology, and historic architecture through educational programs, publications, presentations and exhibits. To cooperate with existing state agencies, academic and cultural organizations to promote the preservation of Gulf Coast history, architecture, archaeology and folklore.

Article IV: The manner in which the directors are appointed will be by a ad hoc steering committee of at least three and no more than five historians, folklorists, archaeologists and other interested persons residing in Florida. The initial appointment of five officer-directors will be by consensus of the organizing committee. Terms of directors and officers shall be for ten years with the option to continue for additional terms if reappointed. Successive ten-year appointments shall thereafter be made by the existing appointed director-officers including a president, vice-president and treasurer who shall meet with of an advisory board of up to six interested persons annually or more often at the discretion of the president, vice-president and treasurer. If an officer resigns, the remaining officers will be authorized to immediately appoint a successor.
