know ALL MEN BY THESE PRESENTS: That the Board of Directors at a special meeting theld on July 29, 1998, at which meeting all Directors were present, unanimously adopted the following Amendments to Article I, Article V and Article VII of the Articles of Incorporation of Florida Association of Nurse Assistants, Inc. There are no members entitled to vote for amendments to the Articles of Incorporation.

Article I is amended to read in its entirety as follows:

ARTICLE I

The name of this corporation shall be Florida Association of Nurse Assistants, Inc. Said corporation/organization is organized exclusively for charitable, religious, educational and scientific purposes, including, for such purposes under Section 501(c)(3) of the Internal Revenue Code (or the corresponding section of any future Federal tax code.)

Article V is amended to read in its entirety as follows: ARTICLE V

- (a) The affairs of the corporation shall be managed by the board of directors. The method of election of directors and members shall be determined by the by-laws of the corporation.
- (b) The board of directors of the corporation shall have the power to admit members of the corporation in such manner, subject to such qualifications, and upon such terms and conditions and with such rights as may be provided from time to time in the by-laws of the corporation.
- (c) No part of the net earnings of the corporation/organization shall insure to the benefit of, or be distributable to its members, trustees, directors, officers or other private persons, except that the corporation/organization shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of Section 501 (c)(3) purposes. No substantial part of the activities of the corporation/organization shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation/organization shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of, or in opposition to, any candidate for public office.

Notwithstanding any other provision of these articles, the corporation/organization shall not carry on any other activities not permitted to be carried on (a) by a corporation/organization exempt from Federal income tax under Section 501(c)(3) of the Internal Revenue Code(or corresponding section of any future Federal Tax Code) or (b) by a corporation/organization, contributions to which are deductible under Section 170

(c)(2) of the Internal Revenue Code (or corresponding section of any future Federal tax code.)

Article VII is amended to read in its entirety as follows: ARTICLE VII

Upon the dissolution of this corporation/organization assets shall be distributed for one or more exempt purposes, with prime consideration for use of tuition re-imbursement programs for CNA/HHA's in accord with standards and criteria set forth by the association by-laws and/or policies and within the
