

## ARTICLES OF INCORPORATION OF "ARGENTINE FUND, INC."

## A FLORIDA NONPROFIT CORPORATION

ARTICLE I. NAME. The name of the Corporation is: ARGENTINE FUND, INC.

**ARTICLE II . PRINCIPAL OFFICE.** The principal place of business and mailing address of this corporation shall be :4100 NE 2<sup>nd</sup> Avenue, Suite 210, Miami, Florida 33137.

**ARTICLE III. PURPOSE.** This Corporation is a non-for-profit Corporation organized under Chapter 617, Florida Statutes. It is not organized for the private gain of any person. The specific purposes of this corporation are:

- A . To generate funds in a lawful way to be donated to the Argentine Florida Chamber of Commerce, Inc. in order to increase the CULTURAL, TECHNICAL AND COMMERCIAL exchange between Argentina and United States.
