ARTICLES OF INCORPORATION  
OF

EFFECTIVE DATE

The undersigned, acting as incorporator of a corporation pursuant to Chap. 617, Florida Statutes, adopts the following Articles of Incorporation:

ARTICLE I

The name of the corporation shall be "WORLD HARVEST MINISTRIES, INC."

ARTICLE II

The principal place of business and mailing address of this corporation shall be 1600 Hwy 27 So., Clermont, FL 34711-34606. The effective date of the corporation shall be January 1, 1998.

ARTICLE III

This corporation is organized for any lawful purpose or purposes for which corporation not for pecuniary profit are permitted and not specifically prohibited under other laws of the State of Florida. The specific purposes for which the corporation is organized is to assist in carrying the gospel to North America and other places on the planet Earth, including distribution of Bibles and Christian Literature; conducting revivals and crusades; and providing financial support to organizations and educational institutions engaged in activities aimed at promoting Christian Fellowship around the World.
