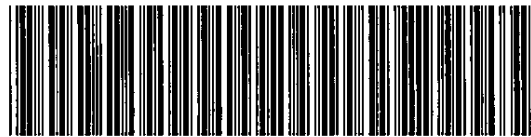

Pursuant to the provisions of Florida Statutes Chapter 617, this Florida Not for Profit Corporation adopts the following amendment to its Articles of Incorporation:


ARTICLE I. The name of the corporation is amended to be:

VILLAGE VIEW COMMUNITY CHURCH, INC.


There are members entitled to vote on a proposed amendment.



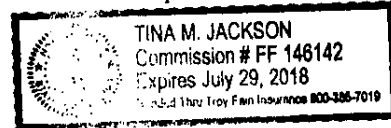


