ARTICLES OF INCORPORATION
OF
MISSION: POSSIBLE OF LAKE LAND INC.
(A Nonprofit Corporation)

ARTICLE I. NAME

The name of this corporation shall be MISSION: POSSIBLE of LAKE LAND, INC.

ARTICLE II. COMMENCEMENT & DURATION

The commencement of this corporation's existence shall be at the time of the filing of these Articles Of Incorporation by the Florida Department of State, Division of Corporations. The corporation's duration will be perpetual.

ARTICLE III. PRINCIPAL OFFICE

ARTICLE IV. PURPOSE

This nonprofit corporation formed in accordance with Florida Statute 617 et seq. and is being organized for the purpose of performing all lawful functions as a charitable, nonprofit organization as defined by the IRS Code Section 501(c)3 engaging in the transaction of any and all business activities, in relation to the RELIEF OF POVERTY, permitted under the laws of Florida and the United States Of America. These activities shall include, but are not limited to,; providing religious services, free meals, clothing and personal items, and emergency relief services.

ARTICLE IX. NONSTOCK BASIS AND DISSOLUTION

The Corporation is organized and shall be operated on a nonstock basis within the meaning of the Florida Not for Profit Corporation Act, and shall not have the power to issue shares of any type or class of stock or other certificates or writings evidencing an ownership or proprietary interest in the Corporation.

In the event of the dissolution of this corporation, or in the event it shall cease to carry out the objects and purposes herein set forth, all business, property, and assets of the Corporation shall go and be distributed pursuant to the statutes and rules and regulations of the Government of the United States of America applicable to such bodies, and, if such do not apply, pursuant to the statutes and laws of the State of Florida. In no way shall any of the assets or property of this Corporation, or the proceeds of any of the assets or property, in the event of dissolution, go or be distributed to individual, natural persons; such distribution may however, be made to other entities that are also nonprofit organizations (e.g. Churches of The Nazarene).

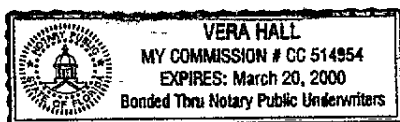
