ARTICLES OF INCORPORATION

OF

JEFFERSON COUNTY BABE RUTH LEAGUE, INC.

a Non-Profit Corporation

The undersigned, acting as incorporator of a corporation under the Florida General Corporation Act, adopt the following articles of incorporation for such corporation.

ARTICLE I - NAME

The name of the Corporation is JEFFERSON COUNTY BABE RUTH LEAGUE, INC.

ARTICLE II - DURATION AND PRINCIPAL ADDRESS

The period of duration of the corporation is perpetual. The principal address is 635 S. Jefferson St., Monticello, FL 32344.

ARTICLE III - PURPOSE

The purpose or purposes for which the corporation is organized are to engage in providing community services including recreation, public meeting facilities, youth and family activities and other functions and activities serving the community, and to own or lease real property to carry out these purposes.

ARTICLE VIII - INDEMNIFICATION

This corporation shall indemnify any officer or director, or any form of officer or director, to the full amount permitted by law.

ARTICLE IX - AMENDMENT

This corporation reserves the right to amend or repeal these Articles of Incorporation. The power to adopt, alter, amend, or repeal the Bylaws of this corporation shall be vested exclusively in its Board of Directors.

ARTICLE X - DISSOLUTION OF CORPORATION

In the event of the dissolution of this corporation, after paying or adequately providing for the debts or obligations of this corporation, the directors, or persons in charge of liquidation, shall grant, convey assign and transfer the remaining assets of this corporation unto:

- 1.) A state, a territory, a possession of the United States, or any political subdivision of any of the foregoing; or to the United States or the District of Columbia, to be used exclusively for public purposes.
 - 2.) A corporation, trust, or community chest, fund or foundation:
- a.) Created or organized in the United States or in any possession thereof, or under the law of the United States, any state or territory, the District of Columbia or any possession of the United States;
- b.) Organized and operated exclusively for religious, charitable, scientific, literary, or educational purposes, or for the prevention of cruelty to children or animals;
- c.) No part of the net earning of which inures to the benefit of nay private shareholder or individual; and
- d.) No substantial part of the activities of which is carrying on propaganda, or otherwise attempting to influence legislation.

The assets transferred to any organization listed above shall be used within the United States, or any of its possessions, exclusively for the purposes specified in subparagraph (b).

No such organization listed above shall qualify for distribution unless such organization shall be an organization, association, fund, or foundation organized and operated exclusively for charitable, religious, scientific or educational purposes which is a tax-exempt, non-profit corporation under the United States Internal Revenue Code, and which is recognized as such by the United States Bureau of Internal Revenue.

If the corporation holds any assets in trust at any time of dissolution thereof, such assets

shall be disposed of in such manner as may be directed by decree of the Superior Court in the county in which the dissolved corporation had its principal office, upon petition thereof by the Attorney General, or any person concerned in the liquidation.
