ARTICLE I

The name of the corporation is **MIAMI CARIBBEAN CLUB, INC.**

ARTICLE II

The principal address, and mailing address of the corporation is: 400 N.E. 180 Drive, North Miami Beach, FL 33162.

ARTICLE III

The purpose for which this corporation is organized is: To establish various teams to participate in the South Florida Cricket Association tournaments and other similar events.

ARTICLE IV

ARTICLE V

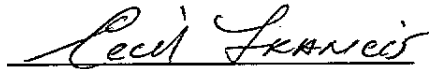
