The undersigned, acting as incorporator(s) of a Corporation pursuant to Chapter 617, Florida Statutes, adopt(s) the following Articles of Incorporation for such corporation:

The period of the duration of this corporation is Perpetual

unless dissolved according to law. Corporate existence shall commence upon 26 December 1997

ARTICLE III

The purpose or purposes for which the corporation is organized are: To conduct services of a religious nature, to establish and maintain a place or places of worship, to solicit funds, to ~~handle and distribute of funds received, to govern itself according to the constitution~~ and bylaws adopted, to purchase and resell to the general public Bibles, Christian Books and supplies, to ordain ministers, to establish and maintain Bible Colleges, Church Schools and other Churches both at home and abroad, to bring people to a personal acquaintance with Jesus Christ through the proclamation of the Gospel.

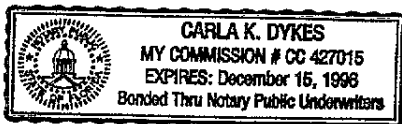
