ARTICLES OF AMENDMENT TO THE ARTICLES OF INCORPORATION  
OF  
DADE-MONROE COUNTIES WAGES COALITION, INC.

Pursuant to Sections 617.1002 and 617.1006 of the Florida Not For Profit Corporation Act, the Articles of Incorporation of the DADE-MONROE COUNTIES WAGES COALITION, INC. (the "Corporation") are hereby amended according to these Articles of Amendment:

FIRST: The name of the Corporation is DADE-MONROE COUNTIES WAGES COALITION, INC.

SECOND: Article I of the Articles of Incorporation is amended in its entirety to read as follows:


ARTICLE I: NAME
