


Some months ago I received notice from your office that the above charity had failed to file its annual report for the year 2000. I immediately called you and advised you that (1) I had never received the form, (2) that I had been assigned to represent FICEA by the Legal Aid Society of Palm Beach County on a volunteer basis and (3) that FICEA was a worthy but struggling organization dedicated to bringing minority teens into the business main stream. You were kind enough to furnish me with a "generic" Uniform Business Report form, which I promptly forwarded to Mr. John M. Collins, the founder and President of FICEA. You were also kind enough to say that your office would waive the increased fee required to file the 2000 report late and would not administratively terminate FICEA.

Yesterday, Mr. Collins called up and requested a meeting. Today, we went over the enclosed form. Also enclosed is my IOTA check for \$61.25 filing fee. Even though this filing is even later than it would have been, please advise me if your office is willing to waive penalties, etc.

You may notice that I have resigned as Registered Agent and Mr. Collins has replaced me. I was very stern with him about filing the 2001 report promptly.
