THE UNDERSIGNED ACTING AS INCORPORATORS OF A CORPORATION PURSUANT TO CHAPTER 617, FLORIDA STATUTES, ADOPT THE FOLLOWING ARTICLES OF INCORPORATION:

ONE: The name of this corporation is The Tampa Myungsung Church, Inc.

TWO: The principal place of business and the mailing address of this corporation shall be 8525 North 78th Street, Temple Terrace, FL 33637.

THREE: This corporation is a nonprofit religious corporation and is not organized for the private gain of any person. It is organized under the general law of the State of Florida, primarily for religious purposes. The specific purposes for which this corporation is organized are to teach, preach and study the gospel of Jesus Christ; to advance its membership in faith, hope and charity; to promote the advancement and glory of Christ's Kingdom by missionary, benevolent and Sunday School work. To do any other act or thing incidental to or connected with the foregoing purposes or in advancement thereof, but not for the pecuniary profit or financial gain of its members, directors, or officers except as permitted under law.

FOUR: The name and address in the State of Florida of this corporation's initial agent for service of process is Kwang Ho Seo, and 8525 North 78th Street, Temple Terrace, FL 33637.

FIVE:

(a) This corporation is organized and operated exclusively for religious purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code.

(b) Notwithstanding any other provision of these Articles, the corporation shall not carry on any other activities not permitted to be carried on (1) by a corporation exempt from federal income tax under Section 501(c)(3) of the Internal Revenue Code or (2) by a corporation contributions to which are deductible under Section 501(c)(3) of the Internal Revenue Code.

(c) No substantial part of the activities of this corporation shall consist of carrying on propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate or intervene in any political campaign (including the publishing or distribution of statements) on behalf of any candidate for public office.

SIX: This corporation shall have perpetual existence or until dissolved according to law.

SEVEN: The names and addresses of the persons appointed to act as the initial Directors of this corporation are:

EIGHT: The manner in which the directors are elected or appointed is stated in the corporate bylaws.

NINE: The property of this corporation is irrevocably dedicated to religious purposes and no part of the net income or assets of the organization shall ever inure to the benefit of any Director, officer, or member thereof or to the benefit of any private person.

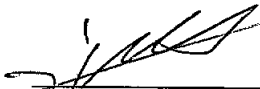
On the dissolution or winding up of the corporation, its assets remaining after payment of, or provision for payment of, all debts and liabilities of this corporation, shall be distributed to a nonprofit fund, foundation, or corporation which is organized and operated exclusively for religious purposes and which has established its tax-exempt status under Section 501(c)(3) of the Internal Revenue Code.

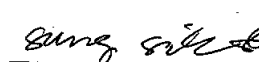
