ARTICLES OF INCORPORATION OF

ST. MARY'S PRIMITIVE BAPTIST CHURCH OF PLANT CITY, INC.

The undersigned, for the purposes of forming a not-for-profit corporation under Chapter 617 of the Florida Business Corporation Act, adopt the following Articles of Incorporation for such corporation.

ARTICLE I

The name of the corporation is ST. MARY'S PRIMITIVE BAPTIST CHURCH OF PLANTEGEY, TRIC

ARTICLE II

The period of duration of the corporation is perpetual.

ARTICLE III

The corporation has been organized exclusively for religious, educational, charitable and scientific purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code, as amended (the "Code"), or the corresponding provision of any future United States internal revenue law, and the corporation may do such things and perform such acts as to accomplish its purposes as the Board of Directors may determine to be appropriate and as are not forbidden y Section 501(c)(3) of the Code, with all the powers conferred on non-profit corporations under the laws of the State of Florida.

The foregoing clauses chall be construed both as objects and powers, in furtherance of, and not in limitation of, the general powers conferred by the laws of the State of Florida, and the enumeration herein of specific objects and powers shall not be held to limit or restrict in any way the general powers of the corporation.

Notwithstanding any provision to the contrary, the following restrictions shall apply:

a. No part of the net earnings of the corporation shall inure to the benefit of any member, trustee, director, or officer of the corporation, or any private individual (except that reasonable compensation may be paid for services rendered to or for the corporation), and no member, trustee, or officer of the corporation or any private individual shall be entitled to share in the distribution of any of the corporate assets on dissolution of the corporation;

- b. No substantial part of the activities of the corporation shall be carrying on propaganda or otherwise attempting to influence legislation, except as otherwise provided by Section 501(h) of the Code. The corporation shall not participate in or intervene in any political campaign on behalf of any candidate for public office;
- c. The corporation shall not carry on any activities not permitted to be carried on by a corporation exempt from federal income tax under Section 501(c)(3) of the Code;
- d. In the event of dissolution, all of the remaining assets and property of the corporation shall, after payment of necessary expenses thereof, be distributed for one or more purposes as shall qualify under Section 501(c)(3) of the Code or to the federal government or to a state or local government for public purpose, or to such organizations as shall qualify under Section 501(c)(3) of the Code, or to another organization to be used in such manner as in the judgment of a county or circuit court judge of the State of Florida will best accomplish the general purposes for which this corporation was organized.

ARTICLE IV

This corporation is organized on a non-stock basis. This corporation shall not issue shares of stock. Membership in the corporation shall be as determined under the bylaws.

ARTICLE V

The initial street address in Florida of the initial registered office of the corporation is: 2171 Pine Ridge Road, Suite D, Naples, Florida 34109. The initial registered agent at such address shall be Michael G. Moore.

ARTICLE VI

The names and address of the initial Incorporator are:

The intitial Board of Directors shall consist of five (5) members, who need not be residents of the State of Florida. The directors shall be elected annually, in accordance with the bylaws.
