ARTICLES OF INCORPORATION

SECRETARY OF STATE

OF

CAMPBELL PARK TENNIS CLUB, INC.

We, the undersigned, hereby associate ourselves together for the purpose of becoming incorporated pursuant to Chapter 617, Florida Statutes as amended of the Laws of the State of Florida, applicable to corporations not for profit under the following proposed Charter:

ARTICLE I

The name of this corporation shall be Campbell Park Tennis Club, Inc., having a business address of 1043 - 19th Avenue South, St. Petersburg, FL 33705.

ARTICLE II

The name and address of the Resident Agent is Alma G. Parham, 1043 - 19th Avenue South, St. Petersburg, FL 33705.

ARTICLE III

The purpose of this corporation is to teach low income, financially disadvantage children who are unable to afford tennis lessons 1) the basic skills of tennis, 2) build self-esteem and 3) to instill in them good sportsmanship qualities.

ARTICLE IV

Any person who resides in Pinellas County, Florida and who subscribed to the purposes of this corporation is

eligible for membership upon approval by a majority vote of the corporation, at any regular meeting of the corporation.

#### ARTICLE V

This corporation shall have perpetual existence.

#### ARTICLE VI

The affairs of this corporation are to be managed by a President, Vice President, Secretary and a Treasurer who shall be elected annually by the members of the corporation as prescribed in the By-Laws.

#### ARTICLE VII

The names of the officers who are to serve until their successors are elected and qualified are as follows:

#### ARTICLE VIII

Future Board of Directors members shall be elected as provided in the bylaws of the corporation.

#### ARTICLE IX

The By-Laws of this corporation may be amended, altered or rescinded by a two-thirds (2/3) majority of the Board of Directors subject to the approval by a three-fifths (3/5) majority of the membership at any regular meeting of the corporation.

#### ARTICLE X

The Articles of Incorporation may be amended, altered or revised by a three-fourths (3/4) vote of the delegation present at any annual meeting providing that all such changes have been approved by a two-thirds (2/3) vote of the Board of Directors prior to the annual meeting.

#### ARTICLE XI

Upon dissolution of the corporation, all of the assets remaining after all costs and expenses of such dissolution shall be distributed by the Board of Directors to such organizations which have qualified for tax exemption under Section 501(c)(3) of the Internal Revenue Code as recommended or superseded to be used for Public Welfare purposes.

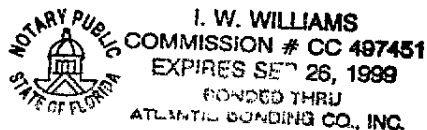
