ARTICLES OF AMENDMENT
to
ARTICLES OF INCORPORATION
of

AMERICAN ENTREPRENEURSHIP INSTITUTE, INC.

Pursuant to the provisions of section 617.1006, Florida Statutes, the undersigned Florida nonprofit corporation adopts the following articles of amendment to its articles of incorporation.

ARTICLE III, paragraph 2 is amended to read as follows:

2. Subject to the limitations of Article III, paragraph 1 herein, the specific purpose for which the corporation is organized shall be: To foster and make contributions for governmental and public projects and programs designed to prevent and overcome the effects of poverty, illiteracy, unemployment, and delinquency; to foster and make contributions for charities involved in work to combat community deterioration and juvenile delinquency; to foster and make contributions for public school-based programs designed to overcome illiteracy and juvenile delinquency; to assist and make contributions to economically disadvantaged or distressed communities to attract new industries to the communities, or to encourage the development or retention of existing industries in the communities.
