THIS AMENDMENT is made this / **day of ______, 2004 by KINGSWOOD DEVELOPMENT COMPANY, LLC., a Florida Limited Liability Company, hereinafter called the "Developer" to the Amended and Restated Articles of Incorporation of Legends Golf & Country Club Master Association, Inc.

WHEREAS the Articles were recorded in Official Records Book 3076, Page 0481, et seq., Public Records of Lee County, Florida; and

WHEREAS, pursuant to Article 12.2 of the Articles, the Developer reserved, in his sole discretion, the right to unilaterally modify or amend the governing documents prior to the community completion date, in any way; and
