ARTICLES OF INCORPORATION OF PAYCO MINISTRIES, INC.

ARTICLE I NAME

The name of this corporation shall be PAYCO MINISTRIES? INC.

ARTICLE II PRINCIPAL OFFICE

ARTICLE III PURPOSE

This corporation is organized for the following purposes:

Any such assets not disposed of shall be disposed of by the Circuit Court for Sumter County, Florida, exclusively for such purposes or to such organization or organizations as said Court shall determine, which are organized and operated exclusively for such purposes.
- (e) Notwithstanding any other provision of these articles, this organization shall not carry on any activities not permitted to be carried on by an organization exempt from Federal Income Tax under Section 501(c)(3) of the Internal Revenue Code as it now
