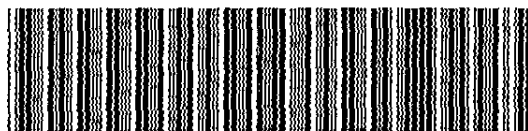

**ARTICLES OF DISSOLUTION

Pursuant to Sections 617.1402 and 617.1403 of the Florida Not For Profit Corporation Act, the undersigned, desiring to effect a dissolution, hereby certifies as follows:

Article I

The name of the corporation is Florida 2012, Inc. (the "Corporation").

Article II

The Corporation has no members. Dissolution of the Corporation was authorized and approved by a resolution adopted by the affirmative vote of a majority of the board of directors at a meeting of the board of directors held on or about November 1, 2002 pursuant to Section 617.1402 of the Florida Statutes.
