Articles of Incorporation

We, the undersigned, acknowledge and file in the Office of the Secretary of State of Florida, for the purpose of forming a corporation not for profit in accordance with the laws of the State of Florida, these Articles of Incorporation as by law provided.

ARTICLE 1.

Name

1. 1 Name: The name of the Corporation shall be MISION "BUEN SAMARITANO", INC. MINISTERIO JESUCRISTO ES EL CAMINO, and the principal office shall be 7831 Sheridan Street, Hollywood, Fla.33024-2535.

ARTICLE 2.

Purposes and Powers

- 2. 1 Purposes: The purposes for which the Corporation is formed are as follows:
 - A. To render Christian guidance and assistance and education through administering the Gospel to all people.
 - B. To participate in and aid organizations involved in Christian outreach and evangelism.
 - C. To acquire, either by deed, gift or purchase, any real estate or personal property to be held in trust for the benefit of the Corporation and its stated purposes.
 - D. To mortgage, sell, or otherwise encumber any such property when such action is deemed to be in the best interests of the Corporation as defined in its stated purposes as a Christian organization.

- 10. 3 Notwihstanding any other provision of these Articles, these purposes are limited to those described in Section 501(c) (3) of the Internal Revenue Code of 1954 or any other corresponding provision of any future United States Internal Revenue law.
- 10. 4 In the event of dissolution, no part of the Corporation's assets shall inure to the benefit of any officer, director or member of the Corporation.
