ARTICLES OF INCORPORATION

of

The undersigned, acting as Incorporator, desiring to form a corporation not-for-profit pursuant to the Florida Business Corporation Act, adopts the following Articles of Incorporation for such corporation:

ARTICLE I
NAME

The name of this corporation is COALITION FOR RESPONSIBLE ECONLOCKHATCHEE DEVELOPMENT, INC..

ARTICLE II
ADDRESS OF PRINCIPAL OFFICE

The principal office and street address of this corporation is COALITION FOR RESPONSIBLE ECONLOCKHATCHEE DEVELOPMENT, INC., 300 Lake Eva Drive, Chuluota, Florida 32766.

ARTICLE III
MEMBERS

3.1 Qualification. Each member of the Coalition shall be a citizen as defined in Section 403.412, Florida Statutes who is interested in the purposes of the Corporation.

3.2 Admission. Members shall be admitted by the directors in the manner determined by the ByLaws.

3.3 Terms. The terms of membership of the members shall be established by the ByLaws.

3.4 Rights. Each member shall be entitled to one vote at meetings of the Corporation, but no member of the Corporation shall have any vested right, privilege or interest of, in or to the assets, functions, affairs or franchise of the Corporation, or any right, interest or privilege which may be transferable or inheritable or which shall continue if the member's membership ceases or while the member is not in good standing.

3.5 Termination. Membership may be terminated in the manner provided by the ByLaws. A membership may be terminated for cause by concurrence of a majority of all

directors of the Corporation after due notice to the member and an opportunity to be heard.

3.6 Meetings. Members shall meet annually at the time provided by the ByLaws and special meetings may be called in the manner provided in the ByLaws.

ARTICLE IV **INITIAL REGISTERED OFFICE AND AGENT**

The street address of the initial registered office of this corporation is 300 Lake Eva Drive, Chuluota, Florida 32766 and the name of the initial registered agent of this corporation at that address is Michael D. Rich.

ARTICLE V **INITIAL BOARD OF DIRECTORS**

A. This corporation shall have four directors initially.

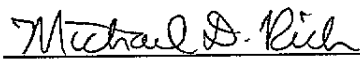
ARTICLE VII
INDEMNIFICATION
